	In the case of an EBAY listing, several questions come to mind.	

First, is there really enough originality in the expression of the listing to be protectable under copyright law? EBAY provides certain options for listings, and sellers can select from those options. Are those choices in

themselves original enough to be protectable? It is difficult to believe that making choices from pre-selected options would contain enough originality to be protectable. On the other hand, it is feasible that the description of an item to be sold on EBAY may have enough originality to be protectable under copyright law, since the choice of words to describe the item may contain original expression. Likewise, the arrangement of items in a photograph added to an EBAY listing may have enough originality to be protectable. Having said this, it is unclear that all descriptions and photographs posted to EBAY contain original expression protectable under copyright law. This is most likely not the case.


Second, are the listings on EBAY really fixed in a tangible form of expression? Do temporary listings exist long enough to meet this standard? This is also unclear in the current set of facts. What constitutes a long enough time of posting to meet the standard?

As you can see, your question raises a number of issues, which may or may not have definitive answers at this point in time. Given the level of uncertainty, I am a bit surprised that an attorney has contacted you regarding this issue, but at this point, he has only contacted you and has not escalated the matter further.

In light of these facts, your best course of action right now would probably be to speak with a local copyright attorney about the specific facts of your listing and also the published case law, particularly the published case law in your jurisdiction. I have not personally researched the published court decisions to see if there have been published decisions, which address any of these issues, but it would be prudent for you to know and understand what the current status of the law is on this issue. After you understand what has been decided to date on this issue, you will be in a position to use that information to make a definitive decision on how to best proceed and respond.
